DEED OF VARIATION
relating to a Funding Agreement
dated 30 May 2013

THIS DEED OF VARIATION is made on

11 July

2017

BETWEEN:

- (1) The Secretary of State for Education ("**Secretary of State**"); and
- (2) Mid Essex Anglican Academy Trust, a charitable company incorporated in England and Wales with registered number 8524638 ("**Company**")

together referred to as the "**Parties**".

INTRODUCTION:

- (A) The Parties entered into a funding agreement dated 30 May 2013 ("**Funding Agreement**") relating to the establishment, maintenance and funding of a school known as Shenfield St. Mary's Church of England Primary School.
- (B) The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.


IT IS AGREED as follows:

1. The Secretary of State and the Company agree that with effect from the date of this Deed the Funding Agreement shall be amended and restated in the form set out at Schedule 1 to this Deed.
2. As varied by this Deed, the Funding Agreement shall remain in full force and effect.
3. This Agreement shall be governed by and interpreted in accordance with English law.


